

Name our frog Competition

Terms and Conditions

This competition ('Competition') is run by Glen Eira City Council ('Council') to promote Carnegie Memorial Swimming Pool ('CMSP') by engaging with the community. Entrants are asked to suggest a name for the frog slide which will be installed as a slide at the new centre. The Competition winner will be the entrant who comes up with the most original, appropriate and creative name.

1. By entering the Competition, entrants accept these terms and conditions of entry ('Conditions').
2. Entry is open only to those who live, work or Study in the City of Glen Eira. Council employees, contractors, Councillors, and their immediate families are not eligible to enter the competition.
3. This is a competition of skill and chance plays no part in determining the winner.
4. The Competition commences on 01/08/2024 and ends 11:59pm 31/08/2024.
5. To be eligible to enter the Competition:
 - (a) the entrant must live, work or Study in the City of Glen Eira.
 - (b) entrants must be aged 2 or over. Entrants under 14 years of age must have their parent or legal guardian's consent to enter the competition;
 - (c) The entrant must complete all requested areas on the entry form located at <https://www.gleneira.vic.gov.au/frog> including providing a suggested name for the frog slide and providing the reason for choosing the name (in 25 words or less);
 - (d) The entry must be submitted online at <https://www.gleneira.vic.gov.au/frog> or by emailing the completed form to projects@gleneira.vic.gov.au
 - (e) The entry must be submitted by 11:59 pm on 31/08/2024.
6. Multiple entries are permitted provided that a different name is suggested in each entry.
7. The suggested name:
 - (a) must comply with Council's values;
 - (b) must not contain any offensive or inappropriate language; and
 - (c) must be original and not infringe the intellectual property rights of any other person.
8. Entries will be judged by a panel of Council staff members on 05/09/2024. Winners will be chosen on the basis of originality and creativity at the judging panel's discretion. Where multiple entries suggest the winning name, the Judging Panel will choose a winner based on the reason provided for choosing the name. The Judging Panel decision is final, and no further correspondence will be entered regarding the Judging Panel's decision.
9. The winning name suggestion will become the name of the frog slide at CMSP, as indicated through signage at CMSP. The winning entrants name will not be present on this signage.
10. The winner will receive a prize of a 12-month Swim School membership, or if Swim School is not applicable, a 12-month CMSP aquatic membership.
11. If an entrant is under 14 years of age on the date a Prize is awarded, it will be awarded to their parent or legal guardian. By approving the entrant's participation or accepting any Prize on the entrant's behalf, the entrant's parent or legal guardian agrees to be bound by these terms and conditions.
12. The prizes are not transferrable, exchangeable, or redeemable for cash and Council is not liable

for any loss (including but not limited to any damage, claim, injury, cost or expense), which is suffered or incurred by any person in connection with redemption or use of any of the prizes.

13. Winners must be able to collect prize in person from GESAC at 200 East Boundary Road, Bentleigh East, VIC, 3165 by 30 November 2024 or at a later date as agreed by Council at its sole discretion.

14. Winners will be notified via email within one week of the Judging Panel making a decision. In the event the winner is unable to comply with these conditions or the prize is unclaimed within 14 days of the winner being announced, Council reserves the right to award the prize to the valid entry judged to be second best in the competition in accordance with clause 8. In such circumstances, the winner will be notified by email within one week of being selected.

15. The winning slide name and first name of the winner will be announced via Glen Eira City Council and/or Glen Eira Leisure's Facebook page and Instagram after confirmation of major prize acceptance.

16. Upon Submission of an entry the proposed frog names contained within the entry will become and remain the Property of Council. By entering the Competition, the entrant assigns Council all rights, including intellectual property rights in the proposed slide name. Entrants consent to Council (or any third party on behalf of Council) dealing with the proposed frog name in any way which may infringe the moral rights of the entrant (including not attributing the entrant as the creator of the frog name and modifying or adapting the frog name).

17. This promotion is in no way affiliated with Facebook or Instagram.

18. Council is not liable for late, lost, incomplete, invalid or incorrectly submitted entries, or illegible, corrupted or misdirected entries, claims or correspondence due to error, omission, alteration, tampering, deletion, theft, destruction, transmission interruption and communications failure or otherwise.

19. Council is not liable for any loss (including but not limited to any damage, claim, injury, cost or expense) suffered or incurred by any person in connection with or arising from the competition or redemption or use of a prize

20. If for any reason any aspect of the Competition is not capable of running as planned, including by reason of tampering, unauthorised intervention, fraud, technical failure or any cause beyond the control of Council, Council may, in its absolute discretion, cancel, terminate, modify or suspend the competition, or invalidate any affected entries.

21. Council reserves the right, at any time, to verify the validity of entries and the eligibility of entrants and to disqualify any entrant who does not meet the eligibility criteria set out in this paragraph 5 or who submits an entry that is not in accordance with these conditions.

22. Council reserves the right to alter or amend these terms and conditions at any time without further recourse to the entrants.

If you do not provide the information requested, you may be ineligible to enter the competition.
