EXECUTIVE SUMMARY

Council is required to determine the term of office for the Mayor and Deputy Mayor in accordance with the Local Government Act 2020 (Act) prior to the election of the Mayor.

The Act states that if the Mayor is elected for a 1-year term, the next election of the Mayor must be held on a day to be determined by Council that is as close to the end of the 1-year term as is reasonably practicable.

The next Local Government elections are scheduled to occur on 26 October 2024 where Councillors will be elected for a 4-year term.

This means that this year, due to the timing of the upcoming 2024 elections, Council can only elect a Mayor and Deputy Mayor for a 1-year term.

RECOMMENDATION

That Council determines the Office of Mayor and Deputy Mayor to be for a 1-year term.

BACKGROUND

Prior to the election of a Mayor, Council must resolve whether the Mayoral term will be set for either one or two years in accordance with s26(3) of the Local Government Act 2020 (the Act).

The term of office for the Mayor also applies to the term of office for the Deputy Mayor as described in s27 of the Act

ISSUES AND DISCUSSION

On 23 November 2022, Council elected Cr Jim Magee as Mayor and Cr Anne-Marie Cade as Deputy Mayor for a 1-year period.

In most years, Council has the option of determining whether the Mayor's term of office is 1 or 2 years. At the conclusion of that term, Council may re-elect the incumbent Mayor for another term determined at that time, or elect another Councillor to be Mayor.

It has been the practice of Glen Eira Councillors to elect the Mayor for a 1-year term with the next Mayoral election to be held as close to the end of that 1-year term as possible.

This year, due to the upcoming 2024 elections Council only has an option to elect a Mayor and Deputy Mayor for a 1-year term.

EXECUTIVE SUMMARY

The Local Government Act 2020 (Act) provides that the term of office for the Mayor be determined prior to the election of the Mayor. This will have occurred on the previous item of the agenda.

The Chief Executive Officer will assume the Chair for the election of the Mayor in accordance with section 25 of the Act and Rule 9 of the Glen Eira City Council Governance Rules.

The Councillor (candidate) who receives an absolute majority of votes will be declared Mayor for the term determined by Council.

The Mayor will assume the Chair for the items on the agenda for this meeting following their election.

RECOMMENDATION

That Council elects a Mayor for Glen Eira City Council for a 1-year term commencing 21 November 2023.

BACKGROUND

The process for the election of the Mayor is conducted in accordance with section 25 of the Local Government Act 2020 and Rule 9 of the Glen Eira City Council Governance Rules. On 23 November 2022, Council elected Cr Jim Magee as Mayor for a 1-year term.

ISSUES AND DISCUSSION

Section 20(a) of the Act provides that the office of Mayor becomes vacant at the time and on the day of the election of the next Mayor.

The Chief Executive Officer (CEO) will act as Chairperson for the election of the Mayor which will be held in accordance with the Local Government Act 2020 and the Glen Eira City Council Governance Rules.

The procedure guiding the election of the Mayor is outlined in Section 9 of Council's Governance Rules. An excerpt from Council's Governance Rules is provided below:

9. Election of the Mayor

Section 25(3)(a) of the 2020 Act provides that the election of the Mayor must be:

- (a) Chaired by the Chief Executive Officer; and
- (b) Subject to section 25 of the 2020 Act, be conducted in accordance with the Governance Rules.
- (1) The Chief Executive Officer must determine the most appropriate time and date for the election of the Mayor, provided the election of the Mayor is held in accordance with the provisions of the 2020 Act.
- (2) The Chief Executive Officer must call for nominations for the office of Mayor from those Councillors present.
- (3) Nominations for the office of Mayor do not require a seconder.
- (4) A Councillor may decline their nomination as a candidate and, if they do, the nomination will be rejected by the Chief Executive Officer.

Section 25(6) of the 2020 Act provides that if only one Councillor is a candidate for Mayor, the Meeting must declare that Councillor to be duly elected as Mayor.

- (5) Where more than one candidate has been nominated, the Chief Executive Officer must conduct a poll with voting to take place for each candidate in turn in the order in which their nomination was received.
- (6) The election of the Mayor must be carried out by a show of hands or such other method approved by the person presiding during the election, provided that voting must not be in secret.
- (7) The Chief Executive Officer must declare elected as Mayor the candidate who receives an Absolute Majority of votes.
- (8) If no candidate receives an Absolute Majority of votes, the candidate with the least number of votes must be eliminated and a further poll conducted in accordance with Sub-Rule 9(5). If there are several candidates, this procedure must be continued until a candidate receives an Absolute Majority of votes.
- (9) For the purpose of eliminating the candidate with the least number of votes, if two or more candidates have the same least number of votes, the candidate to be eliminated must be determined by lot by the Chief Executive Officer.
- (10) If two candidates remain and the vote is tied such that neither candidate receives an Absolute Majority of votes, the following process applies.

- (a) The Chief Executive Officer must conduct a further poll to attempt to break the deadlock; and
- (b) If the second vote is also tied, such that neither candidate receives an Absolute Majority of votes, Council may resolve:
 - that the candidate to be declared as Mayor shall be determined by lot by the Chief Executive Officer; or
 - for a new election to be conducted, in which case the resolution must also include the date and time for the new election.
- (c) If the vote for a Motion to determine the matter as described in Sub-Rule 9(10)(b) is also tied, then the election of the Mayor will be deferred to the next Meeting.
- (d) If, as a result of this Sub-Rule 9(10), the election of the Mayor has been deferred to the next Meeting, and the vote at that next Meeting remains tied such that neither candidate receives an Absolute Majority of votes, then the candidate to be declared as Mayor shall be determined by lot by the Chief Executive Officer.

EXECUTIVE SUMMARY

Council can elect a Deputy Mayor of Glen Eira City Council in accordance with the provisions of the Local Government Act 2020 (the Act).

The election of the Deputy Mayor is conducted in accordance with Rules 10 of the Glen Eira City Council Governance Rules (Governance Rules)

The Rules provide that the process for the election of the Deputy Mayor is the same as for the election of the Mayor but is Chaired by the newly elected Mayor.

The Councillor (candidate) who receives an absolute majority of votes will be declared Deputy Mayor. Where no Councillor (candidate) receives a majority of votes, Rule 9 of the Governance Rules will apply.

RECOMMENDATION

That Council elects a Deputy Mayor for Glen Eira City Council for a 1-year term commencing 21 November 2023.

BACKGROUND

Section 60(1)(d) of the Act provides the election of a Deputy Mayor must be included in the Council's Governance Rules. This is included as Rule 10 of Council's Governance Rules – Role and Election of the Deputy Mayor.

The role of the Deputy Mayor as described under section 21 of the Act is to support the Mayor and stand in for the Mayor in the event they are unable to fulfil their duties for any reason or if the office of Mayor is vacant.

In accordance with these provisions, on 23 November 2022 Council elected Cr Anne-Marie Cade as Deputy Mayor for a 1-year term.

ISSUES AND DISCUSSION

Under Council's Governance Rules, the Mayor Chairs the meeting to elect the Deputy Mayor, although the Chief Executive will conduct the poll should one be required.

The relevant excerpt from Council's Governance Rules is provided below:

10. Role and Election of the Deputy Mayor

Section 21 of the 2020 Act provides the Deputy Mayor must perform the role of the Mayor and may exercise any of the powers of the Mayor if:

- (a) the Mayor is unable for any reason to attend a Council Meeting or part of a Council Meeting; or
- (b) the Mayor is incapable of performing the duties of the office of Mayor for any reason, including illness; or
- (c) the office of Mayor is vacant.
- After the election of a Mayor, Councillors may elect a Deputy Mayor at a Council Meeting that is open to the public.
- (2) The election of the Deputy Mayor is to be Chaired by the Mayor
- (3) Any election of the office of Deputy Mayor:
 - subject to sub-rule 10(4) and 10(5), will be regulated in the same way as the election for the office of the Mayor in rule 9; and
 - be conducted in accordance with section 25(3)(a) and section 27 of the 2020 Act
- (4) The Mayor is ineligible for election to the office of the Deputy Mayor
- (5) The role of the Chief Executive Officer performed in sub-rules 9(2) and 9(4) will be performed by the Mayor

EXECUTIVE SUMMARY

Council's 9 Advisory Committees provide advice and recommendations to Council across a range of areas of strategic importance. Councillors are also appointed to the Audit and Risk Committee and Community Safety Committee along with a number of external bodies and Committees including the Municipal Association of Victoria (MAV), Metropolitan Transport Forum, Eastern Alliance for Greenhouse Action, the Local Government Working Group on Gambling and the Victorian Local Government Association

The proposed appointment of Councillors to each Committee is detailed in the report.

BACKGROUND
