# Mike Craig Elsternwick

#### Question 1:

What is the current level of support for Car Sharing services in the Glen Eira area. Is there plans to expand more parking spaces for car sharing operators and review current parking allocations. Has there been any positive and negative impacts for car sharing vehicles within the Glen Eira area.

#### Answer:

Within the City of Glen Eira, we have 17 car parking spaces for car share operators. The demand for car sharing services is currently driven by the sector not Council. Councils recently adopted Integrated Transport Strategy encourages a range of sustainable transport modes, including car sharing, and this is illustrated through Priority Area 4 – Sustainability and Priority Area 1- Movement.

# Mike Craig Elsternwick

#### Question 2:

With the recent state government decision to allow share hire escooters to operate in Victoria, what is GECC planning in terms of policies and procedures around the use of these devices within GECC boundaries. What do GECC Councillors think of the recent decision? Will GECC local laws officers have powers to address issues with e-scooters? Also, the public would like to know any GECC data on incidents and near misses of e-scooters with pedestrians/vehicles etc for the FY 22-23 and FY 23-24

#### Answer:

As mentioned in answer to Question 1, Council's ITS supports increased use of sustainable transport options including escooters. In Victoria, you can legally ride your escooter however drivers are bound by the regulations set out by the Victorian Government which are enforced by Victoria Police. Council has access to data on injuries and deaths involving scooters through the Department of Transport's Road Crash Information System. In 2022 and 2023 a total of 4 accidents were recorded for each year respectively.

#### **Question 3:**

Thanks for preparing a Green Travel Plan for the Carnegie Pool design as a Green Building. Council's SDAPP (Sustainable Design Assessment in the Planning System) Transport Objective 6 requires new developments 'To minimise car dependency and to ensure that the built environment is designed to promote the use of public transport, walking and cycling'. How many square metres of Koornang Park will be returned to green planted parkland because the Green Travel Plan encourages walking, riding bicycles and public transport; and discourages driving? Old traffic works block access to the pool from the north and Djerring Trail by walking and cycling. What safe new walking and cycling links will be delivered by Council to connect mums and kids to the pool from the 3 nearby rail trails, train, tram and bus?

#### Answer:

A Green Travel Plan seeks to encourage centre visitors and staff to choose walking, cycling, public transport or car-pooling in preference of single occupant car trips where possible.

The Plan does not seek to review the available green space within Koornang and Lord Reserves, however it will consider the new safe walking and cycling connections.

Once the Plan is completed it will be promoted widely with the Glen Eira community and published on our website.
