Isaac Hermann Elwood

Question

With Glen Eira's 72 sports clubs and 45 sports grounds, could council describe: (a) in what ways council supports sporting clubs and their facilities? and (b) whether Councillors, officers and family actively participate in club committees, or events, or memberships?

Answer:

- **a)** Council supports Glen Eira sports clubs in many ways, which includes but is not limited to:
- Routine maintenance activities on the sports grounds, associated ground furniture and club pavilions.
- Undertaking long term planning for recreation Development Strategies and Policies to ensure Council has an understanding about the future needs for our community sporting clubs.
- Completing the necessary minor and major renewal planning for club facilities so that works can occur when required in line with Council's Long Term Financial Planning.
- Supporting clubs in their applications for grant funding to State and Federal Governments.
- Actively working with club members and committees through our Sport Club Liaison service to proactively respond to concerns and support their good governance.
- **b)** Councillors and Officers from time to time will participate in club events in their official roles, for example to open a new facility or attend a special event.

Council is a large organisation with over 1500 staff, many of whom live in Glen Eira or neighbouring municipalities. It is possible that some of those staff members may hold committee roles or be members of local sporting clubs.

Councillors and officers would be obliged to declare their membership as a potential conflict of interest if they were dealing directly with a matter relating to a Club that they were an office bearer or member of.

8.2 DECLARATION OF RATES & CHARGES (2024-25)

Moved: Cr Cade Seconded: Cr Zmood

That Council formally declares the Rates and Charges for the 2024-25 rating year as follows:

1. Amount Intended to be Raised

That an amount of approximately \$140,549,000 (before rebate) is declared as the amount which Council intends to raise by general rates, cultural and recreational lands and annual service charges as follows:

Total		\$140,549,000
•	Annual Service Charge (Waste)	\$27,145,000
•	Cultural and Recreational Lands	\$276,000
•	General Rate	\$113,128,000

2. General Rate

- 2.1 That a General Rate be applied at a uniform rate of 2.7113 cents in each dollar of Net Annual value be declared in respect of the 2024-25 financial year.
- 2.2 That in accordance with Section 4(1) of the *Cultural and Recreational Lands Act 1963*, the amounts payable in respect of the 2024-25 financial year for each rateable land to which that Act applies be as follows:
 - For land owned or occupied by the Melbourne Racing Club, a rate of 76 per cent of the General Rate in the dollar which would otherwise be payable in respect of the land.
 - For land owned or occupied by the Yarra Yarra Golf Club, a rate of 50 percent of the General Rate in the dollar which would otherwise be payable in respect of the land.
 - For land owned or occupied by a sporting organisation operating with liquor and/or gaming licence, a rate of 60 per cent of the General Rate in the dollar which would otherwise be payable in respect of the land.
 - For land owned or occupied by a sporting organisation operating without liquor or gaming licence, a rate of 50 per cent of the General Rate in the dollar which would otherwise be payable in respect of the land.

3. Annual Service Charges

That pursuant to the provisions of Section 162 of the *Local Government Act 1989*, an Annual Service Charge relating to Waste Management be declared for in respect of the 2024-25 financial year for each rateable property as follows:

•	240 Litre bin	\$664.00
•	120 Litre bin	\$332.00
•	Flats Sharing 240 Litre bin	\$332.00
•	Family 240 Litre bin	\$332.00

•	240 Litre Medical	\$332.00
•	Litter Management Charge	\$92.00
•	Additional Recycling	\$70.00
•	Additional Green Waste	\$45.00
•	240 Litre bin (commercial)	\$715.00

4. Rebates

- 4.1 That Council grants to each ratepayer who is an 'eligible recipient' within the meaning of the *State Concessions Act 2004* a combined rebate up to a maximum of \$270 (being an amount contributed by State Government & Council) in respect of the 2024-25 financial year of that land.
- **4.2** The rebate (Council's contribution) referred to in paragraph 4.1 be granted:
 - (a) under section 169(1)(a) of the Local Government Act 1989.
 - (b) to assist the proper development of the municipal district.
- 4.3 It finally be recorded that, in Council's opinion, the rebate referred to in paragraph 4.1 will assist the proper development of the municipal district by partially relieving a specified class of ratepayer of the burden of rate payments; and
- 4.4 The rebate described in paragraph 1 is not intended to affect any right conferred on any person under section 171(4) of the *Local Government Act 1989*.
- **5.** Rates are payable in four instalments due by 30 September 2024, 30 November 2024, 28 February 2025, and 31 May 2025.
- **6.** Council charges interest on outstanding or overdue rates and charges from 1 July 2024 to 30 June 2025.
- 7. The Chief Executive Officer be authorised to levy and recover the general rates, annual service charges and any other amounts described in the report in accordance with the *Local Government Act 1989 and 2020* and *Cultural and Recreational Lands Act 1963*.

That Council endorses the following motion for submission to the 23 August 2024 MAV State Council meeting.

Motion: Collaborating to deliver sustainable, targeted cost of living programs

That the State Council of the Municipal Association of Victoria:

- recognises that Victorian communities continue to struggle with the impact of increases to the cost of living, including the impacts on young Victorians' mental health and future outlooks
- notes that annual inflation has risen another 3.6 per cent between March 2023 and March 2024 according to the Australian Bureau of Statistics, putting further strain on Victorian households
- 3. recognises that all governments must act to maintain resilient and socially connected communities in the face of an increasing cost of living
- 4. notes the cost of living is continuing to place pressure on councils in a constrained financial environment to provide services which build community resilience; and
- 5. requests that the Victorian Government takes proactive steps to investigate new initiatives which provide a greater safety net for those facing significant impacts as a result of the increased cost of living, and which do not exacerbate inflation. This may include investigating proposals such as lowinterest emergency loans or forgoing toll payments and stamp duty for disadvantaged community members.
