## 3D digital model submission

This guide provides technical guidance for submitting 3D digital models for planning related purposes to the Glen Eira City Council.

It is the submitters responsibility to ensure that the digital model is complete and accurately represents the proposal. We reserve the right to request a re-submission of the 3D digital model if these specifications are not met.

## What are 3D digital models used for?

The proposed development's 3D digital model will be inserted into the browser 3D visualisation platform and used for detailed assessment which may include, but is not limited to:

- built form and massing compliance and impacts
- overshadowing impacts on public realm
- heritage fabric response
- context character response
- other planning and urban design related assessment.

3D digital models of live and approved applications may be visualised in our public online 3D visualisation platform for development activity monitoring and visualisation purposes.

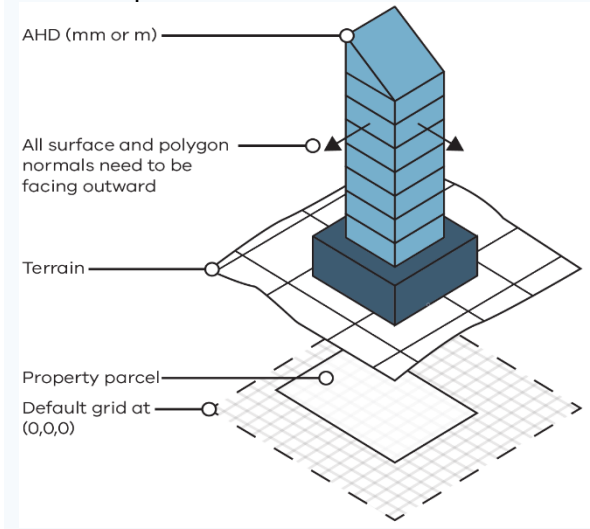
## What is the process for submitting a 3D digital model?
